



Release and Waiver of Liability

OVER 18, READ/SIGN HERE:

I, _____, am aware that Amazing Race Amazing Kids is an athletic event which poses potential risk of injury to its participants and that it is sponsored by a charitable organization, Big Brothers Big Sisters of Central Virginia, Inc. I am aware of the intrinsic dangers of this activity. I understand I may be injured as a result of my negligence, the negligence of others, or through no fault of myself or anyone else, because of the nature of the activity in which I am going to be engaged. I also understand the Race and the activities of its participants are unpredictable.

This waiver shall remain valid unless expressly revoked by the participant or parent/guardian of a minor, in writing, with receipt acknowledgement by Big Brothers Big Sisters of Central Virginia.

With the knowledge of the foregoing, and as an inducement for Big Brothers Big Sisters of Central Virginia to allow me to participate in The Amazing Race, I hereby agree to waive or release any and all rights I or my heirs may have to make a claim against the organization or any members of its Board of Directors, employees and participants, or any landowners over whose land I travel, arising from any damages, injury, or death which I might sustain as a result of my participation in the Race. I further agree to indemnify and hold harmless all of the foregoing from any claims which I might make or which might be made on my behalf by others or which might be made against me by others, arising from my participation in the Race. Furthermore, I agree to indemnify Big Brothers Big Sisters of Central Virginia, its Board of Directors, members or employees, or any landowners, their families, employees or tenants, for any injury, death, loss or damage to any personal property which might occur during the Race or social functions sponsored by Big Brothers Big Sisters of Central Virginia, held in its behalf or for its benefit, when such injury, death, loss or damage occurs on the property of a landowner.

The undersigned Parent or Legal Guardian of the minor child _____ (the "minor") agrees:

1. To waive the rights of myself and all other parents or guardians of the Minor, and of the Minor, to sue Big Brothers Big Sisters of Central Virginia, its officers, directors, managers, employees, agents successors and assigns; and
2. To assume, on behalf of all other parents, guardians and the Minor the risks set forth in this release, in addition to all other risks of the Amazing Race Amazing Kids; and,
3. To indemnify and hold harmless the Big Brothers Big Sisters of Central Virginia, its officers, directors, managers, employees, agents, successors and assigns from any loss, claim, suit or judgment, including, but not limited to, the costs of defending any such claims, including, attorneys' fees, resulting from any injury, death, loss or damage sustained or claimed by Minor or minor's personal representative.

This agreement shall be governed by the laws of the Commonwealth of Virginia.

In the event any portion of this Release shall be declared invalid, unenforceable or void by a court of competent jurisdiction, the remaining provisions of this Release shall remain in full force and effect.
